Public Economy Housing Project (PEH Project) comprising of housing units on fully serviced residential plots of Sector-18 of New Malir Housing Project, MDA Scheme-1 & Sector-6B, 12 & 85 of Taiser Town, Scheme-45, Karachi

1. Malir Development Authority (MDA) will be in receipts of funds through sale of housing units of PEH Project cited above with the scope, estimated cost and duration of project as under:
 - (i) **Scope:** Consultancy services for vetting of design/drawings of internal infrastructure development and construction works including construction supervision" invited on proposed minimum number of professional staff-months basis.
